- Established November 2019
- Rural focus on value-based strategies
- Explore creating an Idaho-specific value-based model
 - Develop a value-based payment model for CAHs that is patient-centered, provides financial incentives to manage the cost of care and reduce unnecessary utilization, and increases primary care investments to enhance the health of Idahoans and rural communities.
