Project Purpose

The Revenue Cycle and Physician Practice Management (RCM/PPM) Assessment and Process Improvement Project identifies opportunities for organizations to implement best practices that result in increased financial performance. The assessment evaluates areas that directly affect the operational and financial management of the organization, and impacts clinic operations, provider productivity and profitability. The project establishes base-line measures for key performance indicators (KPI) to support the organization with ongoing performance improvements to include benchmarking analysis where appropriate.

A report with best practice recommendations and action plan is provided to leadership. Coaching is provided to the team through an action planning session to enhance implementation of recommendations that result in improved reimbursement, increased operational efficiencies and reduced losses where possible.
