eCQM Reporting requirements are aligned between two CMS programs

Calendar Year (CY) 2021 eCQM Reporting Requirements

- The reporting period is two self-selected quarters of CY 2021 data.
- Report on four self-selected eCQMs from the set of nine available eCQMs.
- Submission period deadline: March 31, 2022.*

Data must be submitted through the Hospital Quality Reporting (HQR) Secure Portal as any combination of the following:

- Report QRDA Category I files with patients meeting the initial patient population of applicable measure(s).
- Zero denominator declarations.
- Case threshold exemptions.

Changes Coming Soon! Public Reporting

- eCQM data is not currently included in public reporting from CMS.
- Starting with CY 2021 data, eCQM data will be reported on CMS Care Compare.
- CY 2021 data will be available to the public as early as Fall 2022.
- Hospitals will have the opportunity to review their data before it is made public during a 30-day preview period.

Hybrid Hospital-Wide Readmissions Measure

- A hybrid measure uses both claims data and core clinical data elements from the electronic health records (EHR) for measure calculation.
- Voluntary reporting will be available in 2022 and 2023. Reporting will be mandatory under the Hospital IQR Program starting in 2024. The measure will be publicly reported starting in 2025 (based on 2024 submission).
 - o Initial data submission deadline: **September 30, 2022** for hospitalizations between July 1, 2021, through June 30, 2022.
 - Hospitals that voluntarily report will receive a hospital specific report in spring 2023.
